

**RESOLUTION G2023-14**

**RESOLUTION RESCINDING RESOLUTION G2022-128 AND APPROVING REVISED  
PAY ADJUSTMENTS FOR TOWNSHIP EMPLOYEES FOR FISCAL YEAR 2023**

**WHEREAS**, the Symmes Township Personnel Policy Manual provides for salary adjustments for Township employees;

**WHEREAS**, the Board of Trustees of Symmes Township, Hamilton County, Ohio, has reviewed the 2022 evaluations for Township employees; and

**WHEREAS**, the Township Administrator has recommended that all of the employee receive a raise in their base hourly rate of pay.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of Symmes Township, Hamilton County, Ohio:
