MINUTES OF SYMMES TOWNSHIP SPECIAL MEETING

MARCH 20, 2014

The meeting was called to order at 7:01 p.m. Elected officials present were: Mr. Phil Beck, Mr. Kenneth Bryant, Mrs. Jodie Leis, and Ms. Carol Sims.

Also present: Brian Elliff - Township Administrator; Robert Malloy - Township Law Director.

MRS. SIMS presented the proposed 2014 Permanent Appropriations to the Board for its approval. Mrs. Sims advised this measure is based on the approved Budget and is similar to the temporary appropriations with some exceptions. The total amount of the 2014 Permanent Appropriations is \$8,730,444.81.

MRS. LEIS moved to adopt the following resolution:

Resolution Approving 2014 Permanent Appropriations

Mrs. Leis moved to adopt the following resolution:

RESOLUTION G2014-07

Resolution Setting Date and Time of Public Hearing on the Symmes Township JEDZ-1 Joint Economic Development Zone, Directing JEDZ Materials to be Filed with the Fiscal Officer for Public Inspection, and Directing Publication of Notice

WHEREAS, pursuant to Ohio Revised Code ("ORC") Section 715.691 the Symmes Township Board of Trustees is considering the creation of a Joint Economic Development Zone ("JEDZ") within the Township and adoption of a corresponding JEDZ contract designating the zone; and

WHEREAS, ORC Section 715.691 requires that before the Board of Trustees may enact a resolution approving a contract designating a JEDZ that there must first be held a public hearing concerning the contract and zone ("public hearing"); and

WHEREAS, ORC Section 715.691 requires that at least 30 days' notice be given in a newspaper of general circulation within the Township noticing the time and place of the public hearing; and

WHEREAS, ORC Section 715.691 requires that certain documents be available for public inspection in the office of the Township Fiscal officer during the 30 day period prior to the public hearing.

NOW, THEREFORE, BE IT RESOLVED, by the Symmes Township Board of Trustees, Hamilton County, Ohio:

- Section 1. On April 23, 2014 at the Symmes Township Safety Center located at 8871 Weekly Lane, at 7:00 p.m., a public hearing will be held to consider the proposed Symmes Township JEDZ-1 Joint Economic Development Zone ("JEDZ") and contract designating the zone.
- During the 30 day period prior to the public hearing, the following documents shall be available for public inspection in the office of the Township Fiscal Officer and township administrative office: A copy of the contract designating the JEDZ (incorporated herein at Exhibit "A"); A description of the areas to be included in the JEDZ (incorporated herein as Exhibit "B"); A map in sufficient detail to denote the specific boundaries of the JEDZ area (incorporated herein as Exhibit "C"); and An Economic Development Plan for the JEDZ that includes a schedule for the provision of any new, expanded, or additional services, facilities, or improvements (incorporated herein as Exhibit "D").
- Section 3. The public hearing shall allow for public comment and recommendations on the contract and zone.

Section 4. The Township Fiscal Officer shall publish in a newspaper of general circulation within the township a notice of the time and place of the public hearing at least thirty days prior to the hearing date.

MR. BECK seconded the motion and the roll call vote was as follows: Mrs. Leis - 'aye'; Mr. Beck - 'aye'; Mr. Bryant - 'aye'.

MRS. LEIS moved to adopt the following resolution:

RESOLUTION P2014-01

Resolution Adopting Revised Employment Agreement for Township Administrator

WHEREAS, The Board of Trustees under the authority of Ohio Revised Code Section 505.031 is authorized to contract for the services of a Township Administrator; and

WHEREAS, the Board of Trustees of Symmes Township, Hamilton County, Ohio, entered into an Employment Agreement with Brian Elliff as Township Administrator on January 3, 2011; and

WHEREAS, the parties to that agreement, Brian Elliff individually and the Symmes Township Board of Trustees, desire to replace that agreement with a new agreement that will continue to employ Brian Elliff as the Symmes Township Administrator; and

WHEREAS, the Symmes Township Board of Trustees had determined that a new Employment Agreement is appropriate and necessary.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

- Section 1. That the Employment Agreement set forth on Exhibit "A" attached hereto and incorporated herein, is hereby approved and adopted.
- Section 2. Brian Elliff shall receive for services as Township Administrator the compensation and benefits as set forth in the Employment Agreement.
- Section 3. That this Resolution shall be adopted as an emergency for the reason that it is essential to recognize and adopt the Employment Agreement at the earliest possible date.
