

**RESOLUTION F2019-05**

**RESOLUTION APPROVING TOWNSHIP TEMPORARY APPROPRIATIONS  
FOR FISCAL YEAR 2020**

The Board of Township Trustees of Symmes Township, Hamilton County, Ohio, met in regular session on the 10<sup>th</sup> day of December, 2019, at the office of Symmes Township Trustees with the following members present: Trustee Beck, Trustee Leis and Trustee Bryant and Trustee Phil Beck moved the adoption of the following Resolution:

**Section 3.** The Fiscal Officer is hereby authorized and directed to certify a copy of this Resolution to the County Auditor of Hamilton County.

**Section 4.** Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

**Section 5.** It is hereby certified that all formal actions of the Board of Trustees of Symmes Township, Hamilton County, Ohio relating to the adoption of this Resolution were taken in an open meeting of the Board and that all deliberations of the Board were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**Section 6.** This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
