

RESOLUTION G2019-32

RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO PURCHASE A WORK TRUCK FOR THE ROAD DEPARTMENT FROM BOB ROSS GMC AND KE ROSE IN THE AMOUNT NOT TO EXCEED \$40,000.00

WHEREAS, it has been determined by the Public Works Director that a work truck that is now being used by the Road Department is in need of replacement due to its age and mileage; and

WHEREAS, the Trustees did budget to replace the truck this year; and

WHEREAS, it is necessary to maintain the roads and parks for the safe and effective operation of Symmes Township public works services and the general public and the truck is used to maintain all of the roads in the township; and

WHEREAS, Symmes Township participates in the Ohio State Bid program therefore the Township would not be required to bid out the truck to multiple vendors; and

WHEREAS, the Symmes Township Trustees have decided to replace the work truck for the Road Department and trade in the old vehicle.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. The Symmes Township Trustees hereby authorizes the Township Administrator to purchase a new work truck from Bob Ross GMC and outfit the truck from KE Rose in an amount not to exceed Forty Thousand Dollars and No Cents (\$40,000.00).

Section 2. The funds for the work truck shall be taken from the Road Levy Fund (#2 Motor Vehicle License Fund, #3 Gasoline Tax Fund, #4 Road and Bridge Fund and #23 Permissive Motor Vehicle License Plate Tax Fund).

Section 3. The Fiscal Officer is hereby authorized to make payment to Bob Ross GMC and KE Rose in an amount not to exceed \$40,000.00 with the trade in value once the truck has been delivered and the Public Works Director has given final approval.

Section 4. Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

Section 5. Finds and determines that all formal actions of this Board concerning and relating to the passage of this resolution were taken in open meetings of this Board, and that all deliberations of this Board and any of its committees that resulted in such formal actions were taken in meetings open to the public, in compliance with all legal requirements, including (without limitation) Ohio Revised Code §121.22, except as otherwise permitted thereby.

Section 6. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
