

**RESOLUTION G2020-07**

**RESOLUTION AUTHORIZING THE TOWNSHIP DIRECTOR OF PUBLIC WORKS TO CONDUCT THE NECESSARY CRACK SEAL REPAIRS THROUGHOUT THE TOWNSHIP NOT TO EXCEED TEN THOUSAND DOLLARS (\$10,000.00)**

**WHEREAS**, the Township Road Department is responsible for roads and sidewalks maintenance throughout the township; and

**WHEREAS**, the Director of Public Works has indicated to the Township Administrator that there are multiple areas around the township where the roadways clearly need to be maintained by filling cracks in the pavement; and

**WHEREAS**, it has been determined by the Township Trustees that it is necessary to maintain the roadways and authorizes the Director of Public Works to conduct the necessary crack seal repairs throughout the township not to exceed Ten Thousand Dollars (\$10,000.00).

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

- Section 1.** The Symmes Township Trustees hereby authorize the Township Director of Public Works to conduct the necessary crack seal repairs throughout the Township not to exceed Ten Thousand Dollars (\$10,000.00).
- Section 2.** The funds for the crack seal repairs shall be taken from the Permissive Motor Vehicle Fund (#23).
- Section 3.** The Fiscal Officer is hereby authorized to make payment to the necessary vendors once approval has been given by the Public Works Director.
- Section 4.** Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.
- Section 5.** It is hereby certified that all formal actions of the Board of Trustees of Symmes Township, Hamilton County, Ohio relating to the adoption of this Resolution were taken in an open meeting of the Board and that all deliberations of the Board were in meetings open to the public, in compliance

with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**Section 6.** This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
