

**RESOLUTION G2020-42**

**RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO  
ENTER INTO AN AGREEMENT WITH NATIONAL GUNITE TO PERFORM  
REPAIRS TO STORM WATER PIPES IN UNION CEMETERY IN THE  
AMOUNT OF \$13,725.00**

**WHEREAS**, the Township Road Department is responsible for roads, cemeteries, storm water and sidewalks maintenance throughout the township; and

**WHEREAS**, the Director of Public Works has indicated to the Township Administrator that there are two culvert pipes in Union Cemetery that need repairs; and

**WHEREAS**, it has been determined by the Township Trustees that it is necessary to maintain the roadways, cemeteries and storm water system and authorizes the Township Administrator to enter into an agreement with National Gunitite to make repairs to these two culvert pipes in Union Cemetery.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

**Section 1.** The Symmes Township Trustees hereby authorize the Township Administrator to enter into an agreement with National Gunitite to perform repairs to storm water pipes in Union Cemetery in the amount of Thirteen Thousand Seven Hundred Twenty-Five Dollars and No Cents (\$13,725.00).

**Section 2.** The funds for the repairs shall be taken from the Cemetery Bequest Fund (#6).

**Section 3.** That the appropriations for the Cemetery Bequest Fund (#6) be increased from \$1,500.00 to \$15,225.00.

**Section 4.** The Fiscal Officer is hereby authorized and directed to make payment to National Gunitite once approval has been given by the Public Works Director.

**Section 5.** Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

**Section 6.** It is hereby certified that all formal actions of the Board of Trustees of

Symmes Township, Hamilton County, Ohio relating to the adoption of this Resolution were taken in an open meeting of the Board and that all deliberations of the Board were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**Section 7.** This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
