

**RESOLUTION G2020-99**

**RESOLUTION APPROVING PAY  
ADJUSTMENTS FOR TOWNSHIP EMPLOYEES FOR FISCAL YEAR 2021**

**WHEREAS**, the Symmes Township Personnel Policy Manual provides for salary adjustments for Township employees;

**WHEREAS**, the Board of Trustees of Symmes Township, Hamilton County, Ohio, has reviewed the 2020 evaluations for Township employees; and

**WHEREAS**, the Township Administrator has recommended that all of the employee receive a raise in their base hourly rate of pay.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of Symmes Township, Hamilton County, Ohio:
