RESOLUTION TO ADOPT THE 2017 BUDGET APPROPRIATIONS

WHEREAS, the Symmes Township Trustees are the Chief Legislative Body of the Township; and

WHEREAS, it is necessary to approve the revenue and appropriation budget and the Certificate of the Total Amount from All Sources Available for Expenditure and Balances for 2017 as attached.
