

RESOLUTION G2017-036

RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO SIGN AN AGREEMENT WITH CANTRELL FENCING COMPANY TO INSTALL FENCING ALONG LEBANON ROAD AT SYMMES PARK IN THE AMOUNT NOT TO EXCEED EIGHT THOUSAND DOLLARS (\$8,000.00)

WHEREAS, it has been determined by the Trustees that the fence along Lebanon Road in Symmes Park needs to be replaced and moved to the east to accommodate the new sidewalk that will be installed; and

WHEREAS, the Director of Public Works has recommended to the Township Administrator that the fence be replaced; and

WHEREAS, it is necessary to maintain the parks and all of the buildings for the safe and effective operation of Symmes Township public works services and the general public; and

WHEREAS, the Director of Public Works has reviewed all bids and finds that Cantrell Fence Company to have the best bid; and

WHEREAS, pursuant to Ohio Revised Code §505.261, the Board of Trustees shall devise plans for the maintenance and improvement of the park and award all contracts for maintenance and improvement in the manner provided by the law governing township trustees in awarding contracts for public improvements.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. The Symmes Township Trustees hereby authorizes the Township Administrator to sign an agreement with Cantrell Fence Company to replace the fence at Symmes Park in an amount not to exceed Eight Thousand Dollars and No Cents (\$8,000.00).

Section 2. The funds for the fence shall be taken from the Parks Levy Fund (#12A).

Section 3. The Fiscal Officer is hereby authorized to make payment to Cantrell Fence Company, 2202 State Route 28, Goshen, Ohio 45122, in an amount not to exceed \$8,000.00 upon final approval of the Public

Works Director.

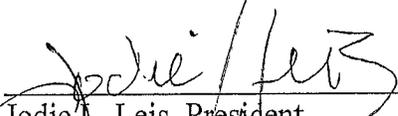

Section 5. This Resolution shall take effect and be enforced from and after the earliest period allowed by law.

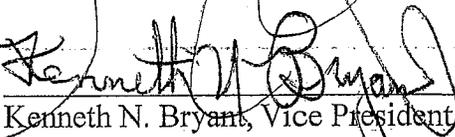
