

RESOLUTION G2017-043

RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO ENTER INTO A CONTRACT WITH DENTAL CARE PLUS FOR PROVIDING DENTAL INSURANCE COVERAGE FOR THE ELECTED OFFICIALS AND FULL-TIME EMPLOYEES OF SYMMES TOWNSHIP

WHEREAS, the Board of Trustees of Symmes Township, Hamilton County, Ohio wishes to provide dental insurance coverage for its full-time Symmes Township Employees and Elected Officials; and

WHEREAS, Symmes Township's policy has been to provide various medical insurance options to its employees and elected officials which includes coverage for the employee and their family; and

WHEREAS, Symmes Township has contracted with Dental Care Plus for dental insurance coverage prior to 2001 and has been renewed each year; and

WHEREAS, the Township Administrator has reviewed all bids with Burnam and Flowers and finds that Dental Care Plus has the best price; and

WHEREAS, the Symmes Township Trustees have determined that Burnham and Flowers will now be the broker for the Township for dental insurance instead of purchasing dental insurance through Hamilton County.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

Section 1. The Symmes Township Trustees hereby authorizes the Township Administrator to enter into a contract with Dental Care Plus for the purpose of providing dental insurance benefits for its full-time employees who work at least 40 hours a week and elected officials for a period of twelve (12) months commencing August 1, 2017.

Section 2. The cost of said contract shall be a total amount not to exceed the following amounts per month commencing August 1, 2017 (0% increase):

- Employee Only – \$35.96
- Employee Plus 1 – \$69.84
- Family – \$101.21

Section 3.

The Fiscal Officer is hereby authorized to pay Dental Care Plus an amount not to exceed the amounts per month specified in Section 2 commencing August 1, 2017, from the General Fund and/or Roads and Parks Fund (if funds are available in the future) upon presentation of proper vouchers thereof.

Section 4.

That Burnam and Flowers will now be the Broker for Dental Insurance Benefits and the Board Authorizes the Township Administrator to sign a letter designating such.

Section 5.

Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

Section 6.

This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
