

**RESOLUTION G2017-055**

**RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO PURCHASE AND INSTALL NEW FRONT OVERHEAD GARAGE DOORS AT THE REMINGTON FIRE STATION FROM BUSHELMAN SUPPLY IN AN AMOUNT NOT TO EXCEED \$30,000.00**

**WHEREAS**, it has been recommended by the Fire Chief and Public Works Director and determined by the Trustees that they would like to replace the current overhead garage doors that have been on the building since 1992; and

**WHEREAS**, the Fire Chief met with the Administrator and Director of Public Works and outlined the need to replace the overhead doors at the Remington Fire Station; and

**WHEREAS**, it is necessary to maintain the building and all of the equipment for the safe and effective operation of Symmes Township Public Safety Divisions and the general public; and

**WHEREAS**, pursuant to Ohio Revised Code §505.37, the Board of Trustees shall provide for the care and maintenance of such fire equipment, and, for these purposes, may purchase, lease, lease with an option to purchase, or construct and maintain necessary buildings, and it may establish and maintain lines of fire-alarm communications within the limits of the township.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

**Section 1.** The Symmes Township Trustees hereby authorizes the Township Administrator to purchase and install new front overhead garage doors at the Remington Fire Station in an amount not to exceed Thirty Thousand Dollars and No Cents (\$30,000).

**Section 2.** The Township Administrator is hereby authorized to sign any and all documents that may be necessary for the purchase and installation of the doors.

**Section 3.** The funds for the new door garage doors shall be taken from the EMS Fund (#14).

**Section 4.** The Fiscal Officer is hereby authorized to make payment to Bushelman Supply in an amount not to exceed \$30,000.00 once the doors have been delivered and installed and the Public Works Director has given final approval of the project.

**Section 5.** Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

**Section 6.** This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
