

**RESOLUTION G2017-058**

**RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO SIGN AN AGREEMENT WITH TEAM ALL SPORTS TO MAKE REPAIRS TO THE SOCCER AND BASEBALL FIELDS AT STONEBRIDGE PARK IN AN AMOUNT NOT TO EXCEED TWENTY-FIVE THOUSAND DOLLARS (\$25,000.00)**

**WHEREAS**, it has been determined by the Trustees that the soccer and baseball fields at Stonebridge Park need to be repaired due to the typical wear and tear from field usage and re-graded because they do not drain properly; and

**WHEREAS**, the Director of Public Works has recommended to the Township Administrator that the fields be regraded and reseeded to improve drainage on the fields; and

**WHEREAS**, it is necessary to maintain the parks, the fields and all of the buildings for the safe and effective operation of Symmes Township public works services and the general public; and

**WHEREAS**, the Director of Public Works has reviewed all bids and finds that Team All Sports to have the best bid; and

**WHEREAS**, pursuant to Ohio Revised Code §505.261, the Board of Trustees shall devise plans for the maintenance and improvement of the park and award all contracts for maintenance and improvement in the manner provided by the law governing township trustees in awarding contracts for public improvements.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of Symmes Township, Hamilton County, Ohio:

**Section 1.** The Symmes Township Trustees hereby authorizes the Township Administrator to sign an agreement Team All Sports to regrade and reseed the fields at Stonebridge Park in an amount not to exceed Twenty- Five Thousand Dollars and No Cents (\$25,000.00).

**Section 2.** The funds for the fields shall be taken from the Parks Levy Fund (#12A).

**Section 3.** The Fiscal Officer is hereby authorized to make payment to Team All Sports, in an amount not to exceed \$25,000.00 upon final approval of

the Public Works Director.

**Section 4.** Upon majority vote does hereby dispense with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

**Section 5.** This Resolution shall take effect and be enforced from and after the earliest period allowed by law.
