



**RESOLUTION P2017-04**

**RESOLUTION CHANGING THE EMPLOYMENT STATUS OF RAY WILLIAMS  
FROM PART-TIME TO FULL-TIME PARKS LABORER IN THE PARKS  
DEPARTMENT**

**WHEREAS**, the Township Trustees are responsible for hiring all personnel in the township when there are vacancies; and

**WHEREAS**, the Township Trustees approved an additional full-time position of Parks Laborer in the Parks Department and set a beginning hourly wage of \$13.00 dollars per hour; and

**WHEREAS**, Ray Williams is by reason of his training and experience competent to fill that position as he has been a part-time employee with the Township since 2013; and

**WHEREAS**, the Public Works Director and Parks Supervisor are recommending that the Trustees change the employment status of Ray Williams from Part-Time to Full-Time Parks Laborer in the Parks Department beginning June 10, 2017.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of Symmes Township, Hamilton County, Ohio that:

**Section 1.** Ray Williams's employment status has been changed from Part-time to Full-time Parks Laborer and will become effective June 10, 2017.

**Section 2.** The Board hereby authorizes an increase in his hourly rate from \$12.00 to \$13.00 and authorizes the Fiscal Officer to pay Ray Williams salary from the appropriate funds.

**Section 3.** That Ray Williams will receive health insurance from his first day of full-time employment.

**Section 4.** The Trustees of Symmes Township upon majority vote do hereby dispense with the requirement that this Resolution be read on two separate days, and hereby authorize the adoption of this Resolution upon its first reading.


**Section 5.** It is hereby determined that all formal actions of the Board of Trustees relating to the adoption of this Resolution were taken in an open meeting of the Board of Township Trustees and that all deliberations of such Board of Trustees were in meeting open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**Section 6.** That this Resolution will become effective by the earliest period allowed by law.




